## Indoor Environmental Quality

- Credit 8.1 **Daylight and Views**—Daylight for 75% of spaces  
Furniture is not included in the scope of this credit.
- Credit 8.2 **Daylight and Views**—Views for 90% of spaces  
Teneo storage furniture may contribute to this credit through the use of low furniture heights, allowing outdoor views to reach building occupants.
- Note The inclusion of furniture is optional for LEED NC.

## Innovation and Design Process

- Credit 1 **Innovation in Design** 5 points
- LEED Innovation Credits can be achieved when a project exceeds the criteria by twice the base requirements of the credit or, in the case of multi-tiered credits, the next tier.
- Specifying systems furniture and seating that meets the requirement of LEED-CI EQ Credit 4.5 Low-Emitting Materials, Systems Furniture and Seating, may earn an innovation credit.
- Teneo storage furniture meets the requirements of both Option A (GREENGUARD® Certified) and Option C (ANSI/BIFMA X7.1 – 2007).
