## Material and Resources

Credit 1.1-1.2 **Construction, Demolition, and Renovation Waste Management** 2 points

Meridian Filing and Storage may contribute to this credit through the use of recyclable packaging. Meridian Filing and Storage packing materials include corrugated cardboard, honeycomb, and polyethylene stretch wrap. These materials are recyclable in many markets, which can reduce landfill disposal.

Credit 2.1-2.5 **Optimize Use of Alternative Materials** 5 points

*Reuse*—Meridian Filing and Storage is designed for durability with a 12-year warranty and can be reused on many building projects. The modular products are easy to reconfigure for reuse.

*Recycled Content*— Meridian pedestals contain 21% post-consumer recycled content and 4% pre-consumer recycled content. Meridian lateral files contain 24% post-consumer recycled content and 5% pre-consumer recycled content. Meridian storage towers contain 24% post-consumer recycled content and 5% pre-consumer recycled content.
